

The central location, high quality of life at moderate prices and tax advantages lure headquarters to Austria.



Footprint in Österreich. More than 300 regional headquarters of prominent multinational companies coordinate transnational business operations from Austria. They span all sectors and industries, from the financial services provider Banco de Brasil and the pharmaceutical company Eli Lily to Citrosuco, one of the world's largest fruit juice producers, the German airline Lufthansa and the electronics specialist Nichicon.

The overall package is convincing. Austria is well-known for the music of Mozart, skiing, the breathtaking Alpine panorama, good food such as the "Wiener Schnitzel" and especially for its hospitality. The high quality of life at relatively affordable prices is the icing on the cake of the tried and tested business location factors comprising good reasons for companies to set up headquarters in Austria:

- Optimal holding location: Group taxation, double taxation agreements and a corporate tax rate of 25 percent
- Central location: Direct access to the markets of South East and Eastern Europe
- Lucrative market: Second most prosperous country in the EU, featuring a market of 50 million people within a radius of 400 kilometers
- Safe and stable: High level of personal security, political stability and legal certainty
- Excellent infrastructure: Hub for air and freight traffic
- International and cosmopolitan: One fifth of the population has a migration background
- Dynamic growth: Vienna is the second largest German-speaking metropolis and ranks among the fastest growing cities in the EU

Central Location between West and East

Headquarters as a driving force for the entire corporate group, one-quarter with R&D competencies

Important role in the entire group. In a survey, two-thirds of the CEOs and CFOs of international headquarters in Austria confirm the enormous importance of Austrian headquarters within their corporate groups. Austria as a headquarters location is the leader with 314 international headquarters, ahead of the competitive locations of Poland, Slovakia, Czech Republic and Hungary, which host a total of 84 international corporate headquarters combined (the law firm Wolf Theiss).


Gateway to the West. The dynamic markets of South East and Eastern Europe are a magnet attracting multinational companies. At the same time, an increasing number of Eastern European firms are using Austria as their springboard to Western Europe. Multinationals such as Lukoil and VTB Bank have established their headquarters in the Alpine Republic. The young Romanian software company TotalSoft recently selected Austria as its hub to serve customers in Central and Eastern Europe as well as in Germany and Switzerland. Austria's excellent infrastructure, quality of life and high educational standards were the decisive factors.

Research and innovation. The good conditions for research and development represent a further advantage for headquarters. The government offers tax benefits to companies carrying out research and promotes the cooperation of the private sector with the scientific community. And it has been quite successful. One quarter of regional headquarters based in Austria have assumed R&D competencies within their respective companies.


Top headquarter locations

An Outstanding Holding Location

Numerous advantages based on Group taxation, double taxation agreements and private foundations

A globally operating company benefits from decisive competitive advantages in maximizing profits which are offered by Austria. Limited liability companies are only subject to a 25 percent corporate income tax and nothing else – no wealth or trade tax at all. Accordingly, the founding of a holding company represents an advantageous approach from a tax perspective.

The advantages of Austria as a holding location:

- More than 80 double taxation agreements have been concluded.
- Profits from foreign subsidiaries can be pooled tax-free in the Austrian holding company.
- Profits from the disposal of foreign subsidiaries are tax-free.
- Losses of foreign subsidiaries can be offset against the domestic profits of the holding (Group taxation).
- The corporate tax rate amounts to 25 percent.
- Interest expenses on borrowings used to acquire third-party equity interests are tax-deductible.
- Provisions can be recognized as reducing net income on the balance sheet.
- Dividends and capital gains from foreign subsidiaries are tax-free for the most part.
- E-government: Austria boasts "Finanz-Online", a system enabling electronic legal transactions on tax matters including appeal proceedings.
- VAT (value added tax) credit balances are paid back quickly in Austria.


The Group taxation scheme for holdings serves as a role model in Europe

Offsetting of profits and losses. The profits and losses of subsidiaries are pooled at the parent company and subject to a unified tax rate. Loss carry-forwards of the group leader are consolidated with the taxable profits of the other companies. The pre-requisite is for the Austrian limited liability company to have a participatory stake in the foreign firm of at least 50 percent and one share. For regional headquarters, this system serves as the basis for greater competitiveness within the Group, and reduces the risk in expanding to new markets.

Private foundations generate tax advantages

There is also the possibility of setting up a foundation, which enables extensive organizational freedom and generates tax advantages. The feature of a private foundation is that one or several founders can devote assets (also different amounts) in the long term exclusively for the purpose of fulfilling the objective stipulated in the deed of foundation without the supervision of administrative authorities.

Stability and legal certainty create reliable conditions for global business.


Headquarters carry out long-term planning and require reliable and stable conditions in order to be able to carry out their management and coordination functions for many countries from a safe haven. Austria not only offers a high level of legal certainty and political stability, but also protection of property and personal security.

Digital administrative procedures: Austria's public administration, which actively supports companies in handling administrative work, functions in a modern, transparent and reliable manner. Austria is a frontrunner in Europe when it comes to open government data and mobile applications, and has a top ranking in terms of e-Government services as indicated by the eGovernment Monitor 2014. More than 90 percent of all companies already take advantage of such services.

High productivity, hardly any strikes. According to the EU Commission, Austria ranks among the top five in the EU-27 with respect to labor productivity per employee in manufacturing industry. Accordingly, it outperforms industrial nations such as Germany, Italy and Great Britain. High productivity goes hand in hand with low unit labor costs and near-zero strike rates.


Labor productivity 2013 in EU comparison

International Employees as the Recipe for Success

A pool of top employees from all over the world is available to headquarters in Austria.

Tops in Europe. Each headquarters located in Austria finds the right employees. More qualified, specialized employees with foreign language skills are available in Austria than in other Western European countries. About 19 percent of the population and every second inhabitant of Vienna have a migration background. Close to three-thirds of all immigrants in Austria come from Central and Eastern Europe. People with a migration background speak an average of three languages and boast above-average qualifications. The percentage of immigrants with academic qualifications (i.e. university degrees) is very high.

Reservoir of top international staff. Companies operating in Austria can turn to highly qualified managers with business development experience in Eastern Europe. This expertise can also be applied to other regions, such as Turkey, North Africa and the CIS countries. Future managers from East and West are also trained and practically educated at customized CEE training programs offered at Austrian universities.

Optimally trained specialists are highly valued by investors from all over the world. The motivation of employees is also extraordinarily high, with Austria ranked fifth in international comparison. Regional headquarters also profit from the close ties between the educational system and the business community. Some 60 public and private universities and academies of applied sciences maintain intensive contacts to the industrial sector.

Know-how for international business. As a North-South and East-West interface, Austria offers strategic advantages for international business. Banks, tax and management consultants, lawyers and advertising agencies have gained extensive experience working with international companies and organizations. On the basis of their know-how and contacts, they serve as reliable partners to regional headquarters responsible for doing business in emerging markets from their Austrian base.

Hotspot for R&D Headquarters

Electric-powered cars, wind turbines and drugs against cancer: Austria promotes the work of R&D headquarters.

The performance of Austria as an innovative business location speaks for itself. The Austrian model of success creates optimal conditions for companies such as Baxter, BMW, Bosch, Infineon and Novartis which bundle their R&D activities and competence centers in Austria. Top-level research, innovative spin-offs, clusters and big players on the global marketplace ensure that inspiring ideas are turned into marketable products and services. The required support accelerates the process, in light of the fact that research is subsidized by the state, the related infrastructure exists and specialized staff is excellently trained.


Whoever conducts research pays less. This bonus is highly valued by international companies. Four out of five multinationals involved in production and about one quarter of regional headquarters carry out strategic research and development work on behalf of the entire Group from their Austrian base. The private sector accounts for more than two-thirds of Austrian R&D expenditures. The government offers tax benefits to companies carrying out research and promotes their cooperation with the scientific community. Companies are entitled to claim a research premium of 10 percent of R&D expenditures.

Funding for the business community. Close to half of direct public funding is designated for non-university research. The business and scientific communities collaborate on projects within the context of the funding initiative "COMET – Competence Centers for Excellent Technologies". Organizations such as the Austrian Institute for Technology (AIT) and JOANNEUM RESEARCH carry out top-of-the-line international research. More than 60 business clusters bundle the strengths of their members and promote trend-setting, future-oriented developments.

Multinationals select Austria.

New companies steadily join the group of the more than 300 headquarters located in Austria. In the years 2013/14, the German airline Lufthansa relocated its CEE sales office from Budapest to Vienna, the Italian firm AB Energy set up its headquarters for eight subsidiaries in Tyrol and the American IT services provider Computer Science Corporation (CSC) opened its regional CEE headquarters in Vienna, similar to Honda and the mail order group Otto.

LUKOIL expands in Austria. Russia's second largest oil company LUKOIL has been managing the Group's international shareholdings in the fields of oil production, refineries and gas stations for more than 15 years via its the Group's holding headquarters based in Austria.


